Attached is an "Open Boulder" flyer I received in the mail today. I have reason to believe that this flyer was sent to all voters in Boulder, at a cost of at least \$10,000 (the flyer does note that "Paid for by Open Boulder, but it does *NOT* reference the Open Boulder 'Unofficial Candidate Committee.). A similar flyer supporting candidates was distributed on doorsteps over the weekend — at an estimated cost of \$5,000. "Open Boulder", to date, has only reported \$2862 in contributions to their "Unofficial andante Committee." So where is all this money coming from? What are the possible remedies and penalties, esp. since this is an ongoing election, and the majority of voters are elected to vote in the next couple days.
